1. Contract length:

- a. Contract period begins the date and time the customer signs the contract and accepts the container after inspection.
- b. Contract ends the date and time Tednologies rep. signs same contract to receive the container back after inspection for damage.

2. TI provides:

- a. Fully operational container(s).
- b. Sanitized container(s).
- c. Container operating at temperature determined by customer order.
- d. Full complement of 6 battery packs per container(unless fewer confirmed on contract)
- e. Container located @ TI Anchorage facility (unless prior arrangements confirmed on contract)
- f. Contract specifying terms.

3. Customer (lessee) provides:

- a. Representative with signature authority for the company.
- b. Provide contact information of person responsible for container location.
- c. Means of payment, net 30 from container return. If leased longer than 30 days, payment for monthly lease due the 30th of every month.
